### **Hello** and **Welcome** to the sixth Cambridge Road Estate Regeneration newsletter.

## Choosing the right development partner

We are at the first stage of the procurement process. Nine potential developers submitted 'an expression of interest' and we have reduced this to a shortlist of four bidders based on their track record and ability to be able to undertake the significant regeneration needed at CRE.

#### Next stages

We are consulting the Resident Steering Group (RSG) on the strategic development brief, which will be sent to the bidders. The RSG has chosen three residents to sit on the procurement panel, who will be evaluating the next two round of bids. On the panel with residents will be the Regeneration Team, other council officers and external financial, legal and technical advisors. The residents panel members will receive training and will continuously feedback to the RSG.

In January 2018, the procurement panel will evaluate the submissions

and **three** bidders will then move to the final stage and submit their final bid in June.

The bidders are not being asked to produce a fully developed scheme as that will take place as part of the masterplanning process with the residents involvement. We will ask the bidders to provide information on how they will carry out the masterplanning and deliver the regeneration on CRE.

In May 2018, you will be able to meet the final three bidders to give them your views and comments on their bids. This will help the bidders to address residents' needs, concerns and aspirations in their final submissions. We will advertise the date of the event in the new year.

We will expect to appoint the developer partner by September 2018 and the masterplanning to start in October.

#### Thank you to the 500 households that have now completed the Housing Needs Survey.

It's important that you complete this survey so we fully understanding your needs and requirements in developing the regeneration proposals. #### £46million of housing zone funds from the Greater London Authority have been released to Kingston Council for the regeneration of Cambridge Road Estate.

Formal approval was given at Growth Committee on 28 September 2017. A £26.6million loan will be made available to fund the buybacks of freehold and leasehold homes and £19.6million of direct grant will help fund the building of affordable homes on Cambridge Road Estate.



Following a community call-in, the full council meeting on 18 October 2017 set up a councillor's task and finish group to look at the appeals procedure for the draft decant policies for tenants and leaseholders.

On 2 November, the group agreed that council officers will work with the call-in organisers and a report will costs the Housing Sub-Committee in March 201
