



## Tackling Antisocial Behaviour (ASB) and crime on the Cambridge Road Estate (CRE)

Kingston Council is delighted that the planning application for Phase 1 of the regeneration has been approved. We know that the CRE looks and feels different now that some of the blocks are becoming empty, prior to demolition.

We are aware that some residents are affected by Antisocial Behaviour (ASB) on the Estate. We understand the devastating impact that ASB can have on the lives of individuals, families and communities if it is not dealt with appropriately. We want to improve how we work with you to try and identify and better respond to these issues.

This newsletter looks at how we can work together to tackle ASB.

Antisocial behaviour is any act that causes or is likely to cause harassment, alarm or distress to one or more persons.

We cannot tackle these issues alone. ASB covers a wide range of issues that often need input from different departments and agencies. We also need help from residents to identify when and where ASB is happening.

With your help, we can better understand what is happening and can work with partner agencies such as the police to take appropriate action to deal with offenders. This may include taking action in relation to any breaches of a tenancy agreement and working with the police to take enforcement action where appropriate.

## Remember

**Always call 999** in an emergency. For example, when a crime is in progress, someone suspected of a crime is nearby, when there is a danger to life or when violence is being used or threatened.

## When reporting ASB please be as specific as you can:

- Which block, property or area did the incident take place in?
- When did the incident take place? Day/time?
- Please take a photo of any evidence and send it to us at: <u>estate\_managers</u> <u>@kingston.gov.uk</u>.

## What happens next?

A member of the housing management team will be in touch with you about the incident within 10 working days of receiving the report. Sooner, if the issue is high risk.

We work with the Community Safety Team/ police/Estate and Youth Services to share information to agree on a plan of action on how to combat what is going on.

## What have we been doing recently to tackle ASB?

- Over the last year, a number of warrants have been executed on the Estate, along with successful court applications for Civil injunctions which relate to a breach of the terms of the tenancy agreement.
- Professional links have been developed with the Metropolitan Police which sees improved collaboration and sharing of information.
- Our Estate Management Team has also been hard at work ensuring that the communal areas on the Estate continue to remain clean.

If you are experiencing high risk ASB, the case will be discussed and checked by our specialist officer, Charlie Aitken, to ensure all possible action is being taken.

When it is rebuilt, the new Estate will meet Secured by Design\* standards. Secured by Design is a standard for the way in which the design of the new homes and the Estate will be improved to help make you both feel and be safer. The new layout will light up unused or dark areas, and give clear views to public spaces from homes, to help make them safer. Vehicles will be kept away from open spaces and traffic calming will keep vehicle speeds down — helping to keep everyone safe.

\*Secured by Design is an initiative approved by the Metropolitan Police proven to reduce crime by up to 87% in new developments.
